2 *Substances and equipment*

- 3 (1) A person must not, subject to subsections (2) to (6):
4 (a) manufacture, import or export any of the following:
5 (i) an HCFC;
6 (ii) methyl bromide;
7 (iii) an SGG;
8 (iv) an HBFC;
9 (v) a stage-1 or stage-2 scheduled substance; or
10 (b) import ODS equipment or SGG equipment.

11 *Exceptions*

- 12 (2) Subsection (1) does not apply to an activity allowed by a licence
13 the person holds.

14 Note 1: See section 13A for the activities allowed by each type of licence.

15 Note 2: No licence allows the manufacture or export of HBFCs.

- 16 (3) Subparagraph (1)(a)(iii) does not apply to manufacturing,
17 importing or exporting an SGG (other than a recycled or used
18 SGG) in circumstances prescribed by the regulations.
- 19 (4) Regulations made for the purposes of subsection (3) must be
20 consistent with Australia's international obligations.
- 21 (5) Paragraph (1)(b) does not apply to a person carrying out an activity
22 in relation to equipment if:
23 (a) the equipment is kept by the person, or by a member of the

6 regulations in relation to the person, the equipment, and the
7 importation are satisfied.

8 Note: In a prosecution for an offence against subsection (7), a defendant
9 bears an evidential burden in relation to the matter in subsection (2),
10 (3), (5) or (6) (see subsection 13.3(3) of the *Criminal Code*).

11 *Penalties*

12 (7) A person commits an offence of strict liability if the person
13 contravenes subsection (1).

14 Penalty: 500 penalty units.

15 (8) Subsection (1) is a *civil penalty provision*.

16 Note 1: Division 7 of Part VIII provides for pecuniary penalties for breaches
17 of civil penalty provisions.

18 Note 2: For maximum penalty, see subsections 65AC(4) and (4A).

4 be involved in regulated HCFC activities engaged in by a licensee

7 year must not exceed the HFC industry limit for the year.
- 8 (3) Regulations made for the purposes of subsection (1) must be
9 consistent with Australia's international obligations.

10 36B Regulated HFC activities

- 11 (1) A *regulated HFC activity* is the manufacture or import of HFCs
12 other than:
13 (a) the import of HFCs that are recycled or used SGGs; or
14 (b) the import of HFCs in SGG equipment; or
15 (c) the manufacture or import of HFCs in circumstances

- 27 (3) For the purposes of subsection (2), the quantity of HFCs exported
28 by an SGG licensee in a period is taken not to include any quantity

2 (direction to export HFCs if quota exceeded).

3 **36C Applications, allocation and size of HFC quotas**

- 4 (1) The regulations may provide in relation to any of the following:
- 5 (a) processes for applying for HFC quotas, including who may
 - 6 apply;
 - 7 (b) processes for the Minister to:
 - 8 (i) allocate HFC quotas for calendar years to SGG
 - 9 licensees; or
 - 10 (ii) vary the size of HFC quotas; or
 - 11 (iii) stop allocated HFC quotas being in force; or
 - 12 (iv) cancel allocated HFC quotas, with the effect that the
 - 13 quotas are taken never to have been in force;
 - 14 (c) the effect on HFC industry limits of the processes mentioned
 - 15 in paragraph (b);
 - 16 (d) the size of HFC quotas, or the method for working out the
 - 17 size of HFC quotas;
 - 18 (e) review of decisions made under regulations made for the
 - 19 purposes of this section.
- 20 (2) Regulations made for the purposes of subsection (1) may provide
- 21 in relation to a matter mentioned in that subsection by providing
- 22 for the matter, or for anything relating to it, to be determined by the
- 23 Minister, including by legislative instrument.

24 **36D Duration of HFC quotas**

25 An HFC quota stays in force until the end of the calendar year for

26 which it is allocated, unless it stops being in force for any other

27 reason before then.

28 **36E Quotas cease when licences cease**

29 An HFC quota allocated to an SGG licensee stops being in force

30 when the licensee's SGG licence is cancelled, or stops being in

31 force for any other reason.

36F Transfer of quotas

Transfer of HFC quota if SGG licence transferred

- (1) If the Minister transfers an SGG licensee's SGG licence under section 19B, the unused part of each HFC quota (if any) allocated to the first licensee for calendar years ending on or after the date of the transfer is taken to have been allocated to the transferee on that date.

Transfer of HFC quota without transferring SGG licence

- (2) An SGG licensee may, without transferring the licensee's SGG licence, transfer to another SGG licensee the unused part of:
- (a) an HFC quota allocated to the first licensee for a calendar year; and
 - (b) each HFC quota (if any) allocated to the first licensee for later calendar years.
- (3) An SGG licensee may, instead of transferring the whole of the unused parts of the HFC quotas mentioned in subsection (2):
- (a) choose a particular percentage; and
 - (b) without transferring the licensee's SGG licence, transfer to another SGG licensee the lesser of the following percentages of each of those quotas:
 - (i) the chosen percentage;
 - (ii) the percentage of the quota that is unused.
- (4) A transfer under subsection (2) or (3) has no effect until the transferor notifies the Minister of the transfer.
- (5) A notice must:
- (a) state the transferee's name, address and licence number; and
 - (b) specify the amount of each HFC quota transferred.
- (6) After a transfer under subsection (2) or (3) takes effect:
- (a) each transferred HFC quota, or each transferred part of an HFC quota, is taken to have been allocated to the transferee; and

- 1 (b) if only part of an HFC quota is transferred—the transferor is
2 taken to have been allocated the untransferred part of the
3 quota.

4 **Division 3—Reserve HFC quotas**

5 **36G Reserve HFC quotas**

6 *Reserve HFC quotas*

- 28 (3) The *reserve HFC quota limit* for a calendar year is the quantity of
29 HFCs, expressed in CO₂e megatonnes:
- 30 (a) prescribed by the regulations in relation to the year for the
31 purposes of this subsection; or

1 (b) worked out in accordance with a method prescribed by the
2 regulations in relation to the year for the purposes of this
3 subsection.

4 (4) The sum of the amounts of all reserve HFC quotas allocated for a
5 calendar year (including any part of that year) must not be more
6 than the reserve HFC quota limit for that year.

7 (5) Regulations made for the purposes of subsection (3) must be
8 consistent with Australia's international obligations.

9 **Division 4—Other provisions**

10 **36H Direction to export HFCs if quota exceeded**

11 (1) The Minister may, by written notice given to an SGG licensee,
12 direct the licensee to export a specified quantity of HFCs by a
13 specified time if:

18 megatonnes, involved in regulated HFC activities

23 (i) the SGG licensee has been allocated a reserve HFC
24 quota that is in force for a period (the *reserve period*) in
25 a calendar year, but has not been allocated an HFC
26 quota for the year; and

27 (ii) the total quantity of HFCs, expressed in CO₂e
28 megatonnes, involved in regulated HFC activities
29 engaged in by the licensee in the reserve period exceeds
30 the reserve HFC quota.

31 Note 1: It is a condition of the SGG licence that the licensee comply with the
32 direction: see subsection 18(1).

33 Note 2: A person requires an SGG licence to export an HFC in most
34 circumstances: see section 13.
